

MindManager Jetpack End User License Agreement

Updated: May 2014

This MindManager Jetpack End User License Agreement (“**Jetpack EULA**”) together with the MindManager Desktop End User License Agreement (“**EULA**”) govern your use of MindManager Jetpack. The EULA is available for review at <http://www.mindjet.com/legal/mindmanager-desktop-eula/>. In the event of a conflict between this Jetpack EULA and the EULA, this Jetpack EULA will govern. All capitalized terms used but not defined herein will have the meanings ascribed to them in the EULA.

BY USING THE MINDMANAGER JETPACK, YOU ACCEPT THIS JETPACK EULA. IF YOU DO NOT ACCEPT THIS EULA, DO NOT USE THE MINDMANAGER JETPACK.

1. All references to “Software” under the EULA will apply to the MindManager Jetpack.
