### **OFFENSIVE CONTENT**

Mindjet does not monitor content, but rather relies on its users to report violations of this Policy through the "Flag This Map," "Report This," and other similar functions within its products and services. Mindjet assumes no responsibility for monitoring any content that is submitted.

You may not publish any content ("**Offensive Content**") that:

- promotes or glorifies hatred, violence, racial or religious intolerance, or organizations which promote such views, or is otherwise defamatory;
- is pornographic, obscene or similarly adult-oriented;
- depicts or promotes illegal activity;
- is excessively or gratuitously violent;
- is highly disturbing to an appreciable number of viewers;
- is unlawful, harmful, harassing, or threatening;
- displays confidential information without proper authority;
- contains viruses or malicious codes, files or programs that disrupt the functionality of computers, software, hardware, or any of Mindjet's services; or
- displays, collects, or stores personal data about others without their permission.

If you post Offensive Content, Mindjet may take one or more of the following remedial actions:

- remove the Offensive Content;
- remove all content that you have posted;
- restrict your ability to publish content; and/or
- any other action as may be deemed appropriate by Mindjet, in its sole discretion, under the circumstances.

Content determined by Mindjet, in its sole discretion, to be non-offensive will not be removed. Mindjet may withdraw or remove your content or terminate your account if you post Offensive Content at anytime in its sole discretion without notice.

### **CLAIMS OF COPYRIGHT INFRINGEMENT**

To be effective, the notification must include the following:
